INVEST a MINUTE Portland Children's Levy Allocation Committee Meeting Recap Oct. 31st, 2016

Meeting news:

The PCL Allocation Committee heard staff recommendations regarding the process/timeline for renewal of current grants, as well as policy options to allocate \$4.4 million of additional, accrued revenue. A brief overview is included below; click <u>here</u> for a more detailed version.

PCL Staff Recommendations for Current Grant Renewal Process

1. Consider renewal of all current grants plus a 2 percent COLA (compounded) pending review of program and financial performance.

2. Provide grantees with staff's renewal recommendations, including grant and financial performance summary, by Feb. 24th, 2017. Grantees have one week, until March 3, 2017, to review and to add comments to the performance summary and return to PCL staff.

3. Final versions of staff recommendations, including any additional grantee comments,

sent to AC members no later than Tuesday, March 7.

4. Renewal decisions to be made by the AC the third week of March, date TBD.

PCL Staff Recommendations for Allocation of Additional Revenue

Staff's recommendations focus on allocating funding to current grantees using the following policy options:

1. Reduce caseloads for home visiting programs/require minimum level of reflective supervision.

- 2. Allocate more FTE to mental health consultation services for home visiting programs.
- 3. Increase funding for summer programming in after-school program area.
- 4. Increase funding for the the Community Childcare Initiative.

Public testimony Monday included current grantees requesting additional funding aimed at assisting their staff with data training/gathering, as well as toward payroll costs so they can remain competitive with the private sector, and increasing funding for preschool programming.

The next AC meeting is scheduled for 2 p.m., Monday, Dec. 5th, with anticipated meetings in March and April where funding decisions will be made on both the renewal process and the investment of the additional revenue.

Going forward, staff will review the public input provided at Monday's meeting along with any written input received between meetings, and make recommended revisions to the renewal process, timeline and/or options for allocating the accrued revenue for the AC at the December meeting. Public input will be taken on the revised recommendations at the December meeting.

System Partners Project

In Spring 2015, the AC allocated \$200,000 for projects that support system partners and systems change. At Monday's meeting, AC members approved a \$25,000 investment for a one-year initiative of the Center for Equity and Inclusion which will support both community-based organizations' participation in a cohort with the goals of improving their equity and inclusion policies and practices, and building PCL competence in advancing equity, diversity and inclusion in its funding practices.

Who we are

The Portland Children's Levy was created by city voters in 2002 and overwhelmingly renewed by the electorate in Fall 2008 and Spring 2013. Funding for the new five-year Levy began July 1, 2014 and added hunger relief as a new funding area.

The Levy is supported through a property tax paid by city of Portland homeowners and projected to generate more than \$15 million annually toward proven programs across the city serving more than 10,000 children and their families in areas of Early Childhood, After School, Mentoring, Child Abuse Prevention/Intervention, Foster Care and Hunger Relief.

The Levy is annually audited and administrative costs do not exceed 5 percent.
